Bounce House Rules:

Remove shoes, eyeglasses, and sharp object before entering

No foreign objects or toys

No food

No front or back flips

No piling on or wrestling others

Do not bounce against the side or near the doorway

Keep hands off the basketball net

If inflatable begins to lose air, make your way out the door

Do not enter inflatable unless an adult is present

Can turnover in high winds. Unload riders immediately if wind excess 25 M.P.H.

An adult from your party must be present at all times to supervise the bounce house

BRANSON REC PLEX POLICIES & PROCEDURES

Use of alcoholic beverages and gambling is prohibited.

Smoking is allowed outside building and fence areas only.

All groups are required to sign a liability waiver.

All groups which meet at the facility are subject to review and may be asked to vacate the building due to disruptive behavior

Payment is due at the time the reservation is made.

No refunds will be given if less than a 48 hour cancelation notification is made.

Branson RecPlex Refund Policy

To request a refund no less than 48 hours in advance of your scheduled reservation, call or stop by the RecPlex during business hours of 8:00am to 4:30pm Monday through Friday. Participants have 30 days after the cancellation of or rain out of a reservation to pick up a refund. After 30 days, the refund will be forfeited and moved into a scholarship fund.
