

OFFENSE INFORMATION FOR BRANSON MUNICIPAL COURT

You have been given a citation requiring your appearance in the Circuit Court of Taney County, Missouri, Municipal Division of Branson. Your court date is listed on your citation.

FOR GOOD REASON you may have the court appearance date changed, but you **MUST** request this change no later than the day before your court appearance date. This request may be made to the Clerk by telephone at 417-335-4578. **PLEASE WAIT 10 DAYS AFTER YOU RECEIVE YOUR CITATION BEFORE CONTACTING THE COURT.**

If you do not want to appear in court and your offense appearing on your citation is listed on the back, you may satisfy the offense(s) by:

B)1. Signing the back of your citation; and

2. Mailing the citation with a Cashier's Check or Money Order for correct amount payable to:
