Registration Fees:

Registration fees must be received at the time of registration.

Team Fee: \$290/ \$270(RD)

Refund Policy: A full refund will be given prior to the first scheduled week of practices. 50% refund within the first 2 weeks of scheduled practices . No refunds thereafter.

You can qualify for the resident (RD) discount if over half (55%) of your players live inside the city limits of Branson. This will be verified by supplying each players name and address on the team roster. If you do not have more than (55%) of your players inside the city limits then you will pay the regular fee.

All players, parents and coaches are required to sign a CODE OF ETHICS, relating to conduct in regards to participation in youth sports, and an liability release waiver form before teams are allowed to participate.

The undersigned being duly aware of the risks and hazards inherent upon engaging in such activities or participating in such activities hereby elects voluntarily to enter upon the premises, and to engage in or participate in said activities knowing that said activities or participation may be hazardous. The undersigned hereby voluntarily assumes all risks of loss, damage, or injury that may be sustained as the result of such participation and activities.
